Terms and Conditions X-mas-campaign
for dive computer i770R
from 1st November 2018 to 24th December 2018

§ 1

Sponsor

The sponsor of the X-mas-campaign is Aqua Lung GmbH, Josef-Schüttler-Straße 12, 78224 Singen, Germany.

§ 2

Eligibility / Participating retailers

- (1) All persons aged 18 and older who reside in Germany, Austria, Switzerland or Denmark and purchase one i770R during the promotional period described below at one of our [Aqua Lung PRO Shops](#) located in Germany, Austria, Switzerland or Denmark are eligible to participate.
- (2) Purchases from retailers other than those referred to above, from private parties or via an online auction are excluded from participating in the X-mas-campaign.
- (3) Aqua Lung employees and their family members, as well as all Aqua Lung PRO Shops participating in the X-mas-campaign, their employees and family members, are not eligible to participate in the promotion.

§ 3

Eligible dive computers / Proof of purchase

- (1) Aqua Lung dive computer i770R is the only product eligible for the campaign. It is only possible to participate in the X-mas-campaign once per eligible dive computer purchased.
- (2) Only participants who can provide the proof of purchase in the form of a copy of the relevant sales receipt from the participating Aqua Lung PRO Shop are eligible to participate in the X-mas-campaign.
- (3) The SK8 Action Cam is only offered in limited quantities.

§ 4

How to participate in the X-mas-campaign

- (1) A dive computer must be purchased from a participating Aqua Lung PRO Shop during the campaign period from

from 22nd October 2018 to 24th December 2018

The date of the receipt / proof of purchase is decisive.

- (2) To participate in the campaign the customer must complete the electronic form at xmas-i770r.aqualung.de. After successful transmission of the data to Aqua Lung GmbH, an automated confirmation of receipt will be send to the participant. This is followed by an examination of Aqua Lung GmbH. After the successful verification, the participant will be asked by e-mail to send a digital copy of the proof of purchase. Only after receipt and examination of the required, complete participation documents (online electronic form and transmission of the proof of purchase) the SK8 Action Cam will be send to the participant.
- (3) Due to the limited number of the SK 8 Action Cam, the distribution takes place after receipt of the electronic registration.
- (4) If the limited number of SK8 Action Cam is no longer available, the participant will be informed by Aqua Lung.
- (5) The deadline for the online application to join the campaign (the transmission of the fully completed electronic form on xmas-i770r.aqualung.de is **7th January 2019**, after this date a participation is not possible anymore.
- (6) For loss of data, specifically in the way of data transmission, and other technical defects the Aqua Lung GmbH disclaims any liability.

The shipping is only possible if the terms and conditions and privacy policy is approved.

§ 5

Shipment of the SK8 Action Cam

- (1) The shipment of the SK8 Action Cam (per participating dive computer) will take place within one month after receipt of the complete participation documents.
- (2) The SK8 Action Cam will only be shipped to participants to Germany, Austria, Switzerland or Denmark.
- (3) In case of loss or damage by the parcel service the Aqua Lung GmbH disclaims any liability.



§ 6

Lapse of the right to the SK8 Action Cam

The right to the SK8 Action Cam lapses if the participant exchanges the dive computer i770R after purchase and registration or makes use of any contradiction or right of return.

§ 7

Privacy notice

By participating in the campaign, the participant consents to having data provided by the participant stored and processed by Aqua Lung GmbH for the duration of the X-mas-campaign. The data will be deleted after processing / at the end of the campaign, as applicable.

§ 8

Miscellaneous

- (1) German law shall apply exclusively to any legal disputes arising from these Terms and Conditions. This is without prejudice to provisions of law restricting the choice of law and to the applicability of mandatory regulations, in particular those of the country in which a customer who is a consumer maintains his/her normal place of residence.
- (2) Should individual provisions of these Terms and Conditions be or become invalid, the validity of the remaining provisions shall remain unaffected.
- (3) The participants legal rights are not restricted by virtue of participation in the X-mas-campaign.
- (4) The promotion is only valid as long as stocks last.
- (5) Aqua Lung GmbH reserves the right to exclude participants from the campaign due to false information, manipulation or the use of unauthorized resources.
